WHAT IS THE INDIAN EMPLOYMENT TAX CREDIT?

Indian Employment tax credits provide benefits for employers who are located on Indian Reservation land and hire enrolled members of the Indian Tribe or their family members. Business located on Casino property are not eligible for this incentive.



WHY DOES THE INDIAN EMPLOYMENT CREDIT EXIST?

Indian Employment Credits are intended to encourage businesses to locate on reservation land and stimulate job growth in their communities.

- The Logic. When your business is located in an Indian Reservation your hiring helps with the
 economic development of that Indian Reservation and the surrounding community. As an
 employer, when you hire Enrolled members of a Native American Tribe that live on or near the
 Indian Reservation the employee and community benefit.
- **The Reward.** For every qualified employee you hire your business secures up to \$4,000 in hiring incentives based on the qualified wages and employee health insurance costs paid to an enrolled member of an Indian tribe or the enrolled member's spouse.
- **The Legislation.** The Indian Employment Credit is currently inactive. Retroactive renewal of this hiring incentive is expected in late 2022 or by mid-2023. Participation in the incentive is strongly encouraged during this time of Indian Employment Credit program hiatus.
